### Sub: Selection Trials for Under-23 [Senior] Asian Wrestling Championship

The 2025 Under-23 [Senior] Asian Free Style, Greco Roman Style & Women Wrestling Championship, scheduled to be held in Vung Tau [Vietnam] from 18<sup>th</sup> to 21<sup>st</sup> June 2025. To ensure the selection of the best wrestlers to represent the country in this prestigious event, the Wrestling Federation of India (WFI) will conduct Selection Trials at as per the following schedule:

#### Selection Trials Schedule & Venue:

1. On 22<sup>nd</sup> May 2025 at 1000 hrs. at STC, Lucknow for Free Style & Greco Roman Style Wrestling Teams.
2. On 23<sup>rd</sup> May 2025 at 1000 hrs. IG Stadium, New Delhi for Women Wrestling Team

#### Eligibility criteria for participation in the Selection Trials:

- All the wrestlers currently training at the National Coaching Camps and participated in the Selection Trials held on 15<sup>th</sup> March 2025, who are under 23 years of age
- Medal winners from the recently held Under-20 National Championship in Kota, who are between 18 and 20 years old.
- Weigh-in will be held on same day as the trial at 0700 hrs. with a 2 kg. weight tolerance allowed.
- The Selection Trial will be supervised by the highly qualified Technical Officials.
- All participants must carry their passport and recent photographs. Entry to the trials will be denied without these documents.
- No past or year 2024 performance will be considered for this trial as the WFI has given the opportunity to all the wrestlers of Under-23 age group through National Events.
- Past performance (including results from 2024) will not be considered. WFI has ensured equal opportunity through recent National Events for all eligible wrestlers in the Under-23 age group.
