

HOW TO FILE NOMINATION FOR W.F.I ELECTIONS, 2023

1. Nomination can be filed by a person whose name is entered in the list of Electoral College published on the 25.07.2023 and duly notified. Likewise, the names proposer and seconder should also be from the list of names included in the Electoral College as notified on the 25.07.2023.
2. For nomination following forms need to be filled
 - (i) **Form 2**
 - (ii) **“Undertaking/declaration by the candidate”**
 - (iii) **Copy of the identity card issued by any Govt. authority having photograph /age/ date of birth of the candidate, his proposer and seconder;**
 - (iv) **No objection certificate (NOC) from employer would be necessary, if candidate is a Govt. servant. This can be filed latest by 11.00 a.m of 02.08.2023.**
3. Nomination can be filed physically and not by e- mail etc. However, nomination papers in original can be filed by the **Authorized Representative** of the candidate who is authorized in writing and relevant papers are produced before the R.O.
4. Nomination papers complete in all respect can be submitted before the R.O from 11.00 a.m to 5.00 p.m during the period 28.07.2023 to 29.07.2023 and 31.07.2023, in Room No. 4A of the I.O.A Building, B-29, Qutub Institutional Area, New Delhi-110016.
5. Copy of Form 2, undertaking is appended.
